

Excerpts from the ELRA end-user agreement

Language Resources, object of this license, are provided by ELRA (hereinafter called PROVIDER) to END-USER after Fachinformationsdienst Linguistik (hereinafter called AGENT) grants approval. AGENT checks the profile and the eligibility of the END-USER and notifies PROVIDER and END-USER of the approval.

END-USER is engaged in *bona fide* language engineering research activities. END-USER, who necessarily belongs to an academic institution, carries out its activities within its academic institution and carries out its research work within this such not-for-profit environment.

END-USER is granted the right to reproduce the **Language Resources** temporarily or permanently, to translate, adapt, arrange and modify by any means the **Language Resources**, if one or all of these acts, which normally require an authorization from the **Language Resources** owner, are necessary to access and make the agreed use of the contents of the **Language Resources**.

END-USER is granted the right to rework and build upon the **Language Resources**, or any component thereof, as necessary or desirable for the purposes of their own internal language engineering research activities. All rights granted hereunder are perpetual, royalty free and worldwide.

END-USER is not permitted to distribute and market any derivative product or service based on all or a substantial part of the **Language Resources**.

END-USER is not permitted to make available to the public all or any substantial part of the contents of the **Language Resources**, evaluated quantitatively and/or qualitatively, by the distribution of copies, by renting, leasing or any other form of distribution, including free or open-source ones.

END-USER acquires no ownership, rights or title in all or any parts of the **Language Resources**.

Without prejudice to the other provisions, the rights referred to herein shall be non transferable to any other entity. The **Language Resources** shall not be transferred to or accessed from any other site.

PROVIDER and AGENT accept no responsibility for the accuracy or completeness of the data or for the consequences of their use. PROVIDER and AGENT give no warranty for merchantability and/or fitness for a particular purpose of the **Language Resources**. **Language Resources** are provided on an "as is with all defects" basis. PROVIDER and AGENT do not guarantee the quality or the adequate nature for the intended use of the data.

END-USER has no right or authority to incur, assume or create, in writing or otherwise, any warranty, liability or other obligation of any kind, express or implied, in the name of or on behalf of PROVIDER, it being intended that each party shall remain an independent contractor responsible for its own actions.
